COMPANY FORMATION MAINLAND LICENSE

Mainland companies are incorporated in accordance with the Department of Economic Development's regulations and are permitted to do business within the UAE, free zones, and offshore. However, if the company is established by a non-UAE national, they can only hold 49% of the company's shares; the rest must be held by a local sponsor. The company is also required to have office space and receive government authorization to incorporate.

COMPANY FORMATION FREE ZONE LICENSE

Free Zones are economic areas with advantageous tax and economic policies where goods and services can be traded within that area. In the UAE, each individual free zone has a specific focus on one or two commercial categories, such as creative and media companies. Although free zone companies are not allowed to trade outside their free zone, you can work with the distributor who can put your goods or services into the local market.







Females below the age of 18 are not eligible to apply for this type of visa unless they are traveling with their parents..

IMMIGRATION SERVICES WORK PERMIT

Whether you moved to the UAE for a job offer or are a school student who just landed their first job, everyone in the UAE workforce needs to ensure that they have a work permit in place, issued by the right authority. For the private sector in the UAE, if your company is on the mainland (and not a free zone), this authority would be the Ministry of Human Resources and Emiratisation (MOHRE)

GOLDEN VISA

In 2019, the UAE introduced a new system for long-term residence visas called Golden Visa. The new visa classification enables foreigners to live, work and study in the UAE without the need of a national sponsor and with 100 percent ownership of their business on the UAE's mainland. These visas will be issued for 5 or 10 years and will be renewed automatically.

GOLDEN VISA DUBAI

The Golden visa is a long-term residence visa that enables foreign talents to live and work or study in the UAE.

Some Important Features

- An entry visa for six months with multiple entries to proceed with residence issuance
- A long-term, renewable residence visa valid for 10 years
- A self-sponsored visa, as there is no need for an employment sponsor
- Ability to stay outside the UAE for more than the usual restriction of six months in order to keep their residence visa valid
- Sponsoring their family members, including spouses and children regardless of their ages
- Sponsoring an unlimited number of domestic helpers allowing family members to stay in the UAE until the end of their permit duration if the primary holder of the Golden visa



passes away.



GOLDEN VISA PORTUGAL

The Portugal Golden Visa program, also known as the residence permit for investment activity (ARI), is a residency by investment scheme designed for non-EU citizens.

Portugal launched the program in October 2012. The main objective was to attract international capital into the country, as it was much in need after the 2008 economic crisis. The program proved to be a great success, raising over €6 billion since then.

Some Important Features

- You can qualify for residency by investing €280,000 which is one of the lowest investment thresholds in Europe.
- You don't have to move to Portugal to keep your residence permit. Staying in the country for seven days on average per year will suffice.
- You can be eligible to apply for Portuguese citizenship in five



years. This is one of the quickest in Europe.

- Once you become a Portuguese citizen, you get visa-free access to 188 countries.



LABOUR FILE

This card, issued by the Ministry of Labour, allows a company to hire staff, obtain work permits and apply for visas on behalf of its employees. The card verifies that the company is registered with the Ministry of Labour and has a registration number.







VAT REGISTRATION


Businesses that make taxable supplies in the UAE must register for VAT if the value of their taxable supplies and imports has exceeded, or is expected to exceed, the mandatory registration threshold of AED 375,000 in the coming 30 days.
